



TOURISM COWICHAN SUNFEST GIVEAWAY » 2017 OFFICIAL RULES AND REGULATIONS

1. DATES

The Giveaway will begin on July 10, 2017. The Giveaway will end at 16:00 PST on July 21, 2017 (the “Closing Date”). Two winners will be chosen for a pair of general admission tickets. The winners will be selected at random from all of the eligible entries.

2. ELIGIBILITY

The contest is open to any Canadian or American resident over the age of 18 years who enters the Giveaway by providing Tourism Cowichan with their submission by signing up to Tourism Cowichan’s Travel Notes Newsletter.

Misrepresentation of age or residency will disqualify the submission. The following person(s) are NOT eligible to win the contest: (a) employees, members of the Tourism Cowichan Board of Directors, contractors, agents and/or representatives of Tourism Cowichan; (b) members of the immediate family (defined as a mother, father, brothers, sisters, sons, daughters and husband or wife), or any person with whom they are domiciled, of any individual described in (a) and; (c) anyone residing in a jurisdiction in which contests of this nature are prohibited. Odds of being selected are dependent on the total number of eligible entries received by the Closing Date of the Giveaway. The greater the number of eligible entries received, the lower the chances of being selected.
